1	271	.1(b)(2)	<p>Initial Custody Assessment. To be completed on all newly admitted inmates prior to housing assignments to determine custody levels.</p> <p>On day of inspection, documentation provided shows that the at least 1 inmate was not classified correctly. Subject has been incarcerated since February 20, 2012.</p>
2	271	.1(b)(3)	<p>Custody Reassessment/Review. A custody reassessment shall be conducted within 30 - 90 days of the Initial Custody Assessment and immediately upon any disciplinary action and/or change in legal status which would affect classification. A documented classification review to determine the necessity for a complete reassessment shall be conducted every 30 - 90 days thereafter.</p> <p>On day of inspection, documentation provided shows that at least 1 inmate has not been reclassified, utilizing the proper form, every 30 - 90 days as required.</p>
3	273	.5(b)	<p>Screening Instrument. An approved mental disabilities/suicide prevention screening instrument shall be completed immediately on all inmates admitted.</p> <p>On day of inspection, documentation provided shows that the suicide screening form was not completed on at least 1 inmate. Inmate has been incarcerated in the Stonewall County Jail since February 20, 2013.</p>
4	275	.2	<p>Corrections Officer Training and Licensing. Personnel employed or appointed as jailers or guards of county jails shall be licensed as per the requirements of the Texas Commission on Law Enforcement Officer Standards and Education under the provisions of the Texas Administrative Code, Title 37. Personnel employed or appointed as jailers or guards at facilities operated under vendor contract with a county or city shall be subject to the same qualifications, training, and testing procedures as county jailers.</p> <p>On day of inspection, it was determined that at least 1 jailer (Sigmon, Timothy) does not currently possess an active Jailer's License, issued by TCLEOSE. Jailer has been employed and working as a jailer since February, 2012.</p>
5	279	.1(2)	<p>Food preparation areas shall be inspected at least annually by health authorities and record kept for each inspection;</p> <p>On day of inspection, documentation could not be provided to show that the annual health inspection at Stonewall County Jail has been completed since December, 2011.</p>
6	285	0.1	<p>Physical Exercise. Each facility shall have and implement a written plan, approved by the Commission, for inmate physical exercise and physical recreation. Documentation of physical exercise and physical recreation shall be maintained for Commission review. Each inmate shall be allowed one hour of supervised physical exercise or physical recreation at least three days per week.</p> <p>On day of inspection, documentation provided does not show that all inmates are offered supervised physical recreation for at least 1 hour, at least 3 days per week as required.</p>
